

## **RETAMA GUN CLUB, INC.**

### **GUN RANGE WAIVER AND RULES**

1. In consideration for receiving permission to participate in the Retama Gun Club, Inc., a Texas non-profit corporation (the "Club"), I hereby release waive, discharge and covenant not to sue the Club, Mike Rhodes, M.L. Rhodes, Ltd., Rhodes Enterprise, Inc., Bentsen Palm Development, Inc., or any of their officers, servants, agents and employees, each herein referred to as "**Releasee**", from any and all liability claims, demands actions and cause of action whatsoever arising out of or relating to any loss, damage or injury, including death, that may be sustained by me, or to any property belonging to me, whether caused by the negligence of others , or otherwise, while participating in the Club or upon any premises controlled or used by the Club (the "Premises"), including but not limited to the gun range facilities operated by the Club (the "Range").

2. I am fully aware of risks and hazards connected with being on the Premises and participating in the activities taking place at the Range, and I am fully aware that there may be risks or hazards unknown to me connected with being on the Premises and participating at the Range, and I hereby elect to voluntarily participate at the Range, to enter upon the Premises and engage in activities knowing that conditions may be hazardous, or may become hazardous or dangerous to me and my property. I voluntarily assume full responsibility for any risks or loss, property damage or personal injury, including death, that may be sustained by me, or any loss or damage to property owned by me, as a result of my being a participant in the Club or at the Range, whether caused by the negligence of others or otherwise.

3. I further hereby agree to indemnify and save and hold harmless all of the **Releasees** from any loss, liability, damage or costs they may incur due to my participation in the Club, at the Range, or on the Premises, whether caused by the negligence of any or all of the releasees, or otherwise.

I understand the rules for using the Range and participating in the Club and have read and initial each item and sign below.

#### **PLEASE Initial each point:**

All persons, including non-shooting spectators and minors, **MUST** register at the office and sign the annual liability waiver. Releasees will issue a Club ID name badge which needs to worn while at the Range.

When two or more shooters are at the Range a designated Range Safety Officer will be assigned, and such Range Safety Office is then responsible for monitoring and directing all activity on the firing line and his/her directions **MUST** be followed at all times. Range Safety Officers have the authority to remove anyone who violates the Club's safety rules or otherwise causes disruption or distraction of other shooters. Range Safety Officers also have the authority to remove any weapon from the line the is not functioning properly or that they otherwise deem unsafe.

The Club operates using the Hot / Cold line concept. When the Range Safety Officer calls the line "Cold", all weapons **MUST** be benched with the action open and visible with the safety in the open position. If the weapon has a removable magazine, it must be removed from the weapon. There will be absolutely **NO** handling of weapons when the line is **COLD**. When the line is **HOT**, no one will proceed beyond the firing line for any reason.

All shooters **MUST** wear Ear and Eye protection whenever the firing line is **HOT**. Spectators **MUST** wear ear protection.

All weapons **MUST** be transported to the firing line securely encased and unloaded with the actions open and safety on. Loading will **ONLY** be allowed on the firing line. Only one firearm will be allowed on the bench at a time.

Firearms are limited to rifles, shotguns, handguns and black powder guns in calibers. Fully automatic weapons or .50 Caliber rifles are not permitted.

No steel core, armor piercing, tracer, exploding, or incendiary ammunition is permitted on the Range. Range Safety Officers are permitted to inspect any ammunition to ensure safety and preserve range integrity.

Alcoholic beverages are NOT permitted at the Range and anyone suspected of being under the influence of alcohol or other substances will be removed from the Club.

Participants must pick up their brass and are required to clean up their targets prior to departure.

There will be no smoking.

Shooting is permitted from sunrise to sunset.

Immediately call CEASEFIRE when unsafe behavior or conditions are observed. All shooters must immediately cease firing.

You MAY NOT handle a firearm if anyone is downrange or beyond the firing line. Move off the firing line and shooting benches when anyone is beyond the firing line
